

Tri-Cities Metropolitan Planning Organization Federal Aid Obligation Report for Federal Fiscal Year 2016 (October, 1 2015 through September 30, 2016)

As required, the Tri-Cities MPO, the Virginia Department of Rail & Public Transportation and the Virginia Department of Transportation have prepared a list of transportation projects that used Federal Aid money between October 1, 2015 and September 30, 2016.

During the 2016 Fiscal Year \$12,195,792 of federal transportation funds were obligated inside the Tri-Cities MPO. At the same time \$447,050 was released from completed projects. Table 1 shows the projects and jurisdictions that received money. Table 2 shows how the money was divided between capital/construction and operations or maintenance. The obligated funds come from six federal funding categories:

- EB/MG Equity Bonus or Minimum Guarantee;
- NHPP National Highway Performance Program;
- STP Surface Transportation Program;
- FTA 5307 Urbanized Area Formula Grants;
- FTA5310 Enhanced Mobility Grants; and
- FTA 5339 Facilities Grants.
